COMPLAINT FOR DAMAGES AND INJUNCTIVE RELIEF

Plaintiffs, Burberry Limited, a United Kingdom company, and Burberry Limited, a New York corporation (collectively “Plaintiffs” or “Burberry”) hereby sue Defendants, the Individuals, Business Entities, and Unincorporated Associations identified on Schedule “A” hereto (collectively “Defendants”). Defendants are promoting, selling, offering for sale, and/or distributing goods bearing and/or using counterfeits and confusingly similar imitations of Burberry’s trademarks and/or unauthorized copies of Burberry’s copyrighted work within this district through various Internet based e-commerce stores operating under the seller names set forth on Schedule “A” (the “E-commerce Store Names”). In support of its claims, Burberry alleges as follows:

JURISDICTION AND VENUE

1. This is an action for damages and injunctive relief for federal trademark counterfeiting and infringement, false designation of origin, cybersquatting, copyright infringement, common law unfair competition, and common law trademark infringement pursuant

to 15 U.S.C. §§ 1114, 1116, 1125(a) and 1125(d), 17 U.S.C. § 101 *et seq*, The All Writs Act, 28 U.S.C §1651(a) and Florida's common law. Accordingly, this Court has subject matter jurisdiction over this action pursuant to 15 U.S.C. § 1121, 17 U.S.C. § 101 *et seq*, and 28 U.S.C. §§ 1331 and 1338. This Court has supplemental jurisdiction pursuant to 28 U.S.C. § 1367 over Burberry's state law claims because those claims are so related to the federal claims that they form part of the same case or controversy.

2. Defendants are subject to personal jurisdiction in this district, because they direct business activities toward and conduct business with consumers throughout the United States, including within the State of Florida and this district through, at least, the Internet based e-commerce stores¹ accessible and doing business in Florida and operating under their E-commerce Store Names. Alternatively, based on their overall contacts with the United States, Defendants are subject to personal jurisdiction in this district pursuant to Federal Rule of Civil Procedure 4(k)(2) because (i) Defendants are not subject to jurisdiction in any state's court of general jurisdiction; and (ii) exercising jurisdiction is consistent with the United States Constitution and laws.

3. Venue is proper in this Court pursuant to 28 U.S.C. § 1391 since Defendants are, upon information and belief, non-residents in the United States and engaged in infringing activities and causing harm within this district by advertising, offering to sell, selling, and/or shipping infringing products into this district.

¹ Certain Defendants use their respective E-commerce Store Names in tandem with electronic communication via private messaging applications and/or services in order to complete their offer and sale of counterfeit versions of Burberry-branded products. Specifically, consumers are able to browse listings of Burberry-branded products online via the respective Defendant's E-commerce Store Name, ultimately directing customers to send inquiries, exchange data, and complete purchases via electronic communication with the Defendant.

THE PLAINTIFFS

4. Plaintiff Burberry Limited is a company duly organized and existing under the laws of the United Kingdom with its principal place of business at Horseferry House, Horseferry Road, London, SW1P 2AW, United Kingdom (“Burberry Limited (UK)”). Plaintiff Burberry Limited is a corporation duly organized pursuant to the laws of the State of New York with its principal place of business at 444 Madison Avenue, New York, New York, 10022 (“Burberry Limited (US)”). Collectively, Burberry Limited (UK) and Burberry Limited (US) are referred to herein as “Burberry.” Burberry is, in part, engaged in the business of manufacturing and distributing throughout the world, including within this district, a variety of high-quality goods under multiple world-famous common law and federally registered trademarks including those identified in Schedule “B” hereto, as well as its copyrighted work, as discussed in Paragraph 15 below and identified in Schedule “C” hereto. Burberry offers for sale and sells its trademarked goods and goods bearing its copyrighted work within the State of Florida, including this district and throughout the United States. Defendants, through the sale and offers to sell counterfeit and infringing versions of Burberry-branded products, are directly and unfairly competing with Burberry’s economic interests in the United States, including the State of Florida, and causing Burberry irreparable harm and damage within this jurisdiction.

5. Like many other famous trademark and copyright owners in the high-quality goods market, Burberry suffers ongoing daily and sustained violations of their trademark rights at the hands of counterfeiters and infringers, such as Defendants herein, who wrongfully reproduce, copy, and/or counterfeit Burberry’s trademarks and copyrighted work for the twin purposes of (i) duping and confusing the consuming public and (ii) earning substantial profits across their e-commerce stores. The natural and intended byproduct of Defendants’ combined actions is the

erosion and destruction of the goodwill associated with Burberry's name and associated intellectual properties and the destruction of the legitimate market sector in which it operates.

6. To combat the indivisible harm caused by the concurrent actions of Defendants and others engaging in similar conduct, each year Burberry expends significant monetary resources in connection with intellectual property enforcement efforts, including legal fees and investigative fees. The exponential growth of counterfeiting over the Internet, including through online marketplace platforms and social media websites, has created an environment that requires companies, such as Burberry, to expend significant resources across a wide spectrum of efforts, in order to protect both consumers and itself from confusion and the erosion of the goodwill embodied in Burberry's brand.

THE DEFENDANTS

7. Defendants are individuals, business entities of unknown makeup or unincorporated associations, each of whom, upon information and belief, either reside and/or operate in foreign jurisdictions, redistribute products from the same or similar sources in those locations, and/or ship their goods from the same or similar sources in those locations to consumers, as well as shipping and fulfillment centers, warehouses, and/or storage facilities within the United States to redistribute their products from those locations. Defendants have the capacity to be sued pursuant to Federal Rule of Civil Procedure 17(b). Defendants target their business activities toward consumers throughout the United States, including within this district, through the simultaneous operation of, at least, their commercial Internet based e-commerce stores under the E-commerce Store Names.

8. Some Defendants operate under their respective E-commerce Store Names in tandem with electronic communication via private messaging applications and/or services, thereby creating an interconnected ecosystem which functions as an online marketplace operation.

9. Defendants use aliases in connection with the operation of their businesses, including but not limited to those identified by Defendant Number on Schedule “A.”

10. Defendants are the past and/or present controlling forces behind the sale of products bearing and/or using counterfeits and infringements of Burberry’s trademarks and/or unauthorized copies of its copyrighted work as described herein.

11. Defendants directly engage in unfair competition with Burberry by advertising, offering for sale, and selling goods each bearing and/or using counterfeits and infringements of one or more of Burberry’s trademarks and/or unauthorized copies of its copyrighted work to consumers within the United States and this district through Internet based e-commerce stores using, at least, the E-commerce Store Names, as well as additional e-commerce store or seller identification aliases not yet known to Burberry. Defendants have purposefully directed some portion of their unlawful activities towards consumers in the State of Florida through the advertisement, offer to sell, sale, and/or shipment of counterfeit and infringing versions of Burberry-branded goods into the State.

12. Defendants have registered, established, or purchased, and maintained their E-commerce Store Names. Defendants may have engaged in fraudulent conduct with respect to the registration of the E-commerce Store Names by providing false and/or misleading information during the registration or maintenance process related to their respective E-commerce Store Names. Many Defendants have anonymously registered and/or maintained some of their E-

commerce Store Names for the sole purpose of engaging in unlawful infringing and counterfeiting activities.

13. Defendants will likely continue to register or acquire new e-commerce store names or other aliases, as well as related payment accounts, for the purpose of selling and/or offering for sale goods bearing and/or using counterfeit and confusingly similar imitations of one or more of Burberry's trademarks or copyrighted work unless preliminarily and permanently enjoined.

14. Defendants' E-commerce Store Names, associated payment accounts, and any other alias e-commerce store names, store identification numbers, and seller identification names used in connection with the sale of counterfeit and infringing goods bearing and/or using one or more of Burberry's trademarks and/or unauthorized copies of Burberry's copyrighted work are essential components of Defendants' online activities and are one of the means by which Defendants further their counterfeiting and infringement scheme and cause harm to Burberry. Moreover, Defendants are using Burberry's famous brand name and/or trademarks to drive Internet consumer traffic to their e-commerce stores operating under the E-commerce Store Names, thereby increasing the value of the E-commerce Store Names and decreasing the size and value of Burberry's legitimate marketplace and intellectual property rights at Burberry's expense.

COMMON FACTUAL ALLEGATIONS

Burberry's Business and Intellectual Property Rights

15. Burberry is the owner of all rights in and to the trademarks identified on Schedule "B" hereto, which are valid and registered on the Principal Register of the United States Patent and Trademark Office (collectively the "Burberry Marks"). The Burberry Marks are used in connection with the manufacture and distribution of high-quality goods in the categories identified in Schedule "B." Additionally, Burberry is the owner of the Copyrighted Work entitled "TB

Pattern” under the United States Copyrighted Work Registration Number VA 2-145-324 (the “Burberry Copyrighted Work”), as identified on Schedule “C” hereto. Burberry’s ownership and registration of the Burberry Copyrighted Work precedes Defendants’ infringement as alleged herein. True and correct copies of the Certificates of Registration for the Burberry Marks and the Burberry Copyrighted Work are attached hereto as Composite Exhibit “1.” The Burberry Marks and the Burberry Copyrighted Work are referred to collectively herein as the “Burberry Intellectual Property.”

16. The Burberry Intellectual Property has been used in interstate commerce to identify and distinguish Burberry’s high-quality goods for an extended period of time.

17. The Burberry Intellectual Property has been used by Burberry in commerce long prior in time to Defendants’ use of copies of that intellectual property. The Burberry Intellectual Property has never been assigned or licensed to any of the Defendants in this matter.

18. The Burberry Marks and the Burberry Copyrighted Work are symbols of Burberry’s quality, reputation, and goodwill and have never been abandoned. Burberry has carefully monitored and policed the use of the Burberry Intellectual Property.

19. The Burberry Intellectual Property is well known and famous and has been for many years. Burberry expends substantial resources developing, advertising and otherwise promoting the Burberry Intellectual Property. The Burberry Marks qualify as famous marks as that term is used in 15 U.S.C. § 1125(c)(1).

20. Burberry extensively uses, advertises, and promotes the Burberry Intellectual Property in the United States in connection with the sale of high-quality goods. Burberry has expended substantial resources to extensively advertise and promote its goods and associated trademarks and copyrights.

21. As a result of Burberry's efforts, members of the consuming public readily identify merchandise bearing or sold under the Burberry Intellectual Property as being high-quality goods sponsored and approved by Burberry.

22. Accordingly, the Burberry Intellectual Property has achieved secondary meaning among consumers as identifiers of high-quality goods.

23. Genuine goods bearing and/or using the Burberry Intellectual Property are widely legitimately advertised and promoted by Burberry, its authorized distributors, and unrelated third parties via the Internet. Visibility on the Internet, particularly via Internet search engines and social media platforms is important to Burberry's overall marketing and consumer education efforts. Thus, Burberry expends significant monetary and other resources on Internet marketing, including search engine optimization ("SEO") strategies, search engine marketing ("SEM") strategies, and social media strategies. Those strategies allow Burberry and its authorized retailers to fairly and legitimately educate consumers about the value associated with the Burberry brand and the goods sold thereunder. Similarly, many of Defendants' e-commerce stores are indexed on search engines and compete directly with Burberry for space and consumer attention in the search results.

Defendants' Infringing Activities

24. Defendants are each promoting, advertising, distributing, selling, and/or offering for sale goods in interstate commerce bearing and/or using counterfeit and confusingly similar imitations of one or more of the Burberry Marks or the Burberry Copyrighted Work (the "Counterfeit Goods") through at least the e-commerce stores operating under the E-commerce Store Names. Specifically, Defendants are using the Burberry Marks to initially attract online consumers and drive them to Defendants' e-commerce stores operating under the E-commerce Store Names. Defendants are each using identical copies of one or more of the Burberry Marks

and/or the Burberry Copyrighted Work for different quality goods. Burberry has used the Burberry Intellectual Property extensively and continuously before Defendants began offering counterfeit and confusingly similar imitations of Burberry's merchandise.

25. Defendants' Counterfeit Goods are of a quality substantially different than that of Burberry's genuine goods. Defendants are actively using, promoting and otherwise advertising, distributing, selling and/or offering for sale substantial quantities of their Counterfeit Goods with the knowledge and intent that such goods will be mistaken for the genuine high-quality goods offered for sale by Burberry, despite Defendants' knowledge that they are without authority to use the Burberry Marks or the Burberry Copyrighted Work. The net effect of Defendants' actions is likely to cause confusion of consumers, at the time of initial interest, sale, and in the post-sale setting, who will believe all of Defendants' goods offered for sale in or through Defendants' e-commerce stores are genuine goods originating from, associated with, and/or approved by Burberry.

26. Defendants advertise their e-commerce stores, including their Counterfeit Goods offered for sale, to the consuming public via e-commerce stores on, at least, the E-commerce Store Names. In so doing, Defendants improperly and unlawfully use one or more of the Burberry Marks or the Burberry Copyrighted Work without Burberry's permission.

27. As part of their overall unlawful scheme, Defendants are, upon information and belief, concurrently employing and benefitting from substantially similar advertising and marketing strategies based, in large measure, upon an illegal use of counterfeits and infringements of the Burberry Intellectual Property. Specifically, Defendants are using counterfeits and infringements of Burberry's famous name and the Burberry Intellectual Property to make their e-commerce stores selling unauthorized goods appear more relevant and attractive to consumers

searching for both Burberry and non-Burberry goods and information online. By their actions, Defendants are jointly contributing to the creation and maintenance of an illegal marketplace operating in parallel to the legitimate marketplace for Burberry's genuine goods. Defendants are causing individual, concurrent, and indivisible harm to Burberry and the consuming public by (i) depriving Burberry and other third parties of their right to fairly compete for space online and within search engine results and reducing the visibility of Burberry's genuine goods on the World Wide Web, (ii) causing an overall degradation of the value of the goodwill associated with the Burberry Marks by viewing inferior products in either the pre or post sale setting, and/or (iii) increasing Burberry's overall cost to market its goods and educate consumers about its brand via the Internet.

28. Defendants are concurrently conducting and targeting their counterfeiting and infringing activities toward consumers and likely causing unified harm within this district and elsewhere throughout the United States. As a result, Defendants are defrauding Burberry and the consuming public for Defendants' own benefit.

29. At all times relevant hereto, Defendants in this action had full knowledge of Burberry's ownership of the Burberry Intellectual Property, including its exclusive right to use and license such intellectual property and the goodwill associated therewith.

30. Defendants' use of the Burberry Marks and/or the Burberry Copyrighted Work, including the promotion and advertisement, reproduction, distribution, sale, and offering for sale of their Counterfeit Goods, is without Burberry's consent or authorization.

31. Defendants are engaging in the above-described unlawful counterfeiting and infringing activities knowingly and intentionally or with reckless disregard or willful blindness to Burberry's rights for the purpose of trading on Burberry's goodwill and reputation. If Defendants'

intentional counterfeiting and infringing activities are not preliminarily and permanently enjoined by this Court, Burberry and the consuming public will continue to be harmed.

32. Defendants' above identified infringing activities are likely to cause confusion, deception, and mistake in the minds of consumers before, during, and after the time of purchase. Moreover, Defendants' wrongful conduct is likely to create a false impression and deceive customers, the public, and the trade into believing there is a connection or association between Burberry's genuine goods and Defendants' Counterfeit Goods, which there is not.

33. Moreover, at least Defendant Number 1 (the "Cybersquatting Defendant") has registered its E-commerce Store Name using a mark that is nearly identical and/or confusingly similar to at least one of the Burberry Marks, (the "Cybersquatted E-commerce Store Name").

34. The Cybersquatting Defendant has registered and/or used the Cybersquatted E-commerce Store Name with the bad faith intent to profit from the Burberry Marks.

35. Defendants do not have, nor have they ever had, the right or authority to use the Burberry Marks. Further, the Burberry Marks have never been assigned or licensed to be used on the e-commerce store operating under the Cybersquatted E-commerce Store Name.

36. Upon information and belief, the Cybersquatting Defendant has provided false and/or misleading contact information when applying for the registration of its Cybersquatted E-commerce Store Name or has intentionally failed to maintain accurate contact information with respect to the registration of the Cybersquatted E-commerce Store Name.

37. The Cybersquatting Defendant has never used the Cybersquatted E-commerce Store Name in connection with a bona fide offering of goods or services.

38. The Cybersquatting Defendant has not made any bona fide non-commercial or fair use of the Burberry Marks on a website accessible under the Cybersquatted E-commerce Store Name.

39. The Cybersquatting Defendant has intentionally incorporated at least one of the Burberry Marks in its Cybersquatted E-commerce Store Name to divert consumers looking for Burberry's Internet e-commerce store to their own Internet e-commerce store for commercial gain.

40. Given the visibility of Defendants' various e-commerce stores and the similarity of their concurrent actions, it is clear Defendants are either affiliated, or at a minimum, cannot help but know of each other's existence and the unified harm likely to be caused to Burberry and the overall consumer market in which they operate because of Defendants' concurrent actions.

41. Although some Defendants may be physically acting independently, they may properly be deemed to be acting in concert because the combined force of their actions serves to multiply the harm caused to Burberry.

42. Defendants' payment and financial accounts, including but not limited to those specifically set forth on Schedule "A," are being used by Defendants to accept, receive, and deposit profits from Defendants' trademark counterfeiting and infringing and unfairly competitive activities connected to their E-commerce Store Names and any other alias e-commerce store names being used and/or controlled by them.

43. Further, Defendants, upon information and belief, are likely to transfer or secret their assets to avoid payment of any monetary judgment awarded to Burberry.

44. Burberry has no adequate remedy at law.

45. Burberry is suffering irreparable injury because of Defendants' unauthorized and wrongful use of the Burberry Intellectual Property. If Defendants' counterfeiting and infringing,

cybersquatting, and unfairly competitive activities are not preliminarily and permanently enjoined by this Court, Burberry and the consuming public will continue to be harmed while Defendants wrongfully earn a substantial profit.

46. The harm sustained by Burberry has been directly and proximately caused by Defendants' wrongful reproduction, use, advertisement, promotion, offers to sell, and sale of their Counterfeit Goods.

COUNT I - TRADEMARK COUNTERFEITING AND INFRINGEMENT
PURSUANT TO § 32 OF THE LANHAM ACT (15 U.S.C. § 1114)

47. Burberry hereby adopts and re-alleges the allegations set forth in Paragraphs 1 through 46 above.

48. This is an action for trademark counterfeiting and infringement against Defendants based on their use of counterfeit and confusingly similar imitations of the Burberry Marks in commerce in connection with the promotion, advertisement, distribution, offering for sale, and sale of the Counterfeit Goods.

49. Specifically, Defendants are promoting and otherwise advertising, selling, offering for sale, and distributing goods bearing and/or using counterfeits and/or infringements of one or more of the Burberry Marks. Defendants are continuously infringing and inducing others to infringe the Burberry Marks by using one or more of them to advertise, promote, sell, and/or offer to sell counterfeit and infringing goods bearing and/or using the Burberry Marks.

50. Defendants' concurrent counterfeiting and infringing activities are likely to cause and are causing confusion, mistake, and deception among members of the trade and the general consuming public as to the origin and quality of Defendants' Counterfeit Goods.

51. Defendants' unlawful actions have caused and are continuing to cause unquantifiable and irreparable harm to Burberry and are unjustly enriching Defendants with profits at Burberry's expense.

52. Defendants' above-described unlawful actions constitute counterfeiting and infringement of the Burberry Marks in violation of Burberry's rights under § 32 of the Lanham Act, 15 U.S.C. § 1114.

53. Burberry has suffered and will continue to suffer irreparable injury while Defendants are earning a substantial profit due to Defendants' above-described activities if Defendants are not preliminarily and permanently enjoined.

COUNT II - FALSE DESIGNATION OF ORIGIN
PURSUANT TO § 43(a) OF THE LANHAM ACT (15 U.S.C. § 1125(a))

54. Burberry hereby adopts and re-alleges the allegations set forth in Paragraphs 1 through 46 above.

55. Defendants' Counterfeit Goods bearing, using, offered for sale, and sold using copies of at least one of the Burberry Marks and/or the Burberry Copyrighted Work have been widely advertised and offered for sale throughout the United States via the Internet under the E-commerce Store Names.

56. Defendants' Counterfeit Goods bearing, offered for sale, and sold using copies of at least one of the Burberry Marks and/or the Burberry Copyrighted Work are virtually identical in appearance to Burberry's genuine goods. However, Defendants' Counterfeit Goods are different in quality. Accordingly, Defendants' activities are likely to cause confusion in the trade and among consumers as to at least the origin or sponsorship of their Counterfeit Goods.

57. Defendants have used in connection with their advertisement, offer for sale, and sale of their Counterfeit Goods, false designations of origin and false descriptions and

representations, including words or other symbols and designs, which tend to falsely describe or represent such goods and have caused such goods to enter into commerce in the United States with full knowledge of the falsity of such designations of origin and such descriptions and representations, all to Burberry's detriment.

58. Defendants have each authorized infringing uses of one or more of the Burberry Marks and/or the Burberry Copyrighted Work in Defendants' advertisement and promotion of their counterfeit and infringing branded goods. Some Defendants have also misrepresented to members of the consuming public that the Counterfeit Goods they advertise and sell are genuine, non-infringing goods.

59. Additionally, Defendants are simultaneously using counterfeits and infringements of one or more of the Burberry Marks and/or the Burberry Copyrighted Work to unfairly compete with Burberry and others for space within organic and paid search engine and social media results. Defendants are thereby jointly (i) depriving Burberry of a valuable marketing and educational space online, which would otherwise be available to Burberry, and (ii) reducing the visibility of Burberry's genuine goods on the World Wide Web and across social media platforms.

60. Defendants' above-described actions are in violation of Section 43(a) of the Lanham Act, 15 U.S.C. § 1125(a).

61. Burberry has no adequate remedy at law and has sustained both individual and indivisible injury caused by Defendants' concurrent conduct. Absent an entry of an injunction by this Court, Burberry will continue to suffer irreparable injury to its goodwill and business reputation while Defendants are earning a substantial profit.

COUNT III - CLAIM FOR RELIEF FOR CYBERSQUATTING
PURSUANT TO §43(d) OF THE LANHAM ACT (15 U.S.C. §1125(d))
(Against Defendant Number 1 Only)

62. Burberry hereby adopts and re-alleges the allegations set forth in Paragraphs 1 through 46 above.

63. At all times relevant hereto, Burberry has been and still is the owner of the rights, title, and interest in and to the Burberry Marks.

64. The Cybersquatting Defendant has acted with the bad faith intent to profit from the Burberry Marks and the goodwill associated with the Burberry Marks by registering and using its Cybersquatted E-commerce Store Name.

65. The Burberry Marks were already distinctive and famous at the time the Cybersquatting Defendant registered its Cybersquatted E-commerce Store Name.

66. The Cybersquatting Defendant has no intellectual property rights in or to the Burberry Marks.

67. The Cybersquatted E-commerce Store Name is identical to, confusingly similar to or dilutive of one or more of the Burberry Marks.

68. The Cybersquatting Defendant's conduct is done with knowledge and constitutes a willful violation of Burberry's rights in the Burberry Marks. At a minimum, the Cybersquatting Defendant's conduct constitutes reckless disregard for and willful blindness to Burberry's rights.

69. The Cybersquatting Defendant's actions constitute cybersquatting in violation of §43(d) of the Lanham Act, 15 U.S.C. §1125(d).

70. Burberry has no adequate remedy at law.

71. Burberry has suffered and will continue to suffer irreparable injury while the Cybersquatting Defendant is earning a substantial profit due to the above-described activities if this Defendant is not preliminarily or permanently enjoined.

COUNT IV – COPYRIGHT INFRINGEMENT
PURSUANT TO 17 U.S.C. § 501
(Against Certain Defendants Only)

72. Plaintiffs hereby adopt and re-allege the allegations set forth in Paragraphs 1 through 46 above.

73. At least one Defendant has infringed and will continue to infringe the Burberry Copyrighted Work, at least, by copying, selling, advertising, reproducing, and placing into a chain of distribution, unauthorized copies or derivations of Burberry's copyrighted work in violation of 17 U.S.C. § 501.

74. Defendants are knowingly and willingly engaging in the copyright infringement alleged herein for the purpose of profiting therefrom.

75. Burberry has suffered and will continue to suffer irreparable injury while Defendants are earning a substantial profit due to Defendants' above-described activities if Defendants are not preliminarily and permanently enjoined.

COUNT V - COMMON LAW UNFAIR COMPETITION.

76. Burberry hereby adopts and re-alleges the allegations set forth in Paragraphs 1 through 46 above.

77. This is an action against Defendants based on their promotion, advertisement, distribution, sale, and/or offering for sale of goods bearing and/or using marks that are virtually identical to one or more of the Burberry Marks and/or the Burberry Copyrighted Work in violation of Florida's common law of unfair competition.

78. Specifically, Defendants are promoting and otherwise advertising, selling, offering for sale, and distributing goods using and/or bearing counterfeits and infringements of one or more of the Burberry Marks and/or the Burberry Copyrighted Work. Defendants are also each using counterfeits and infringements of one or more of the Burberry Marks to unfairly compete with Burberry and others for (i) space in search engine and social media results across an array of search terms and (ii) visibility on the World Wide Web.

79. Defendants' infringing activities are likely to cause and are causing confusion, mistake, and deception among consumers as to the origin and quality of Defendants' e-commerce stores as a whole and all products sold therein by their use of the Burberry Marks and/or the Burberry Copyrighted Work.

80. Burberry has no adequate remedy at law and is suffering irreparable injury because of Defendants' actions, while Defendants are earning a substantial profit.

COUNT VI - COMMON LAW TRADEMARK INFRINGEMENT

81. Burberry hereby adopts and re-alleges the allegations set forth in Paragraphs 1 through 46 above.

82. Burberry is the owner of all common law rights in and to the Burberry Marks.

83. This is an action for common law trademark infringement against Defendants based on their promotion, advertisement, offering for sale, and sale of their Counterfeit Goods bearing and/or using one or more of the Burberry Marks.

84. Specifically, each Defendant is promoting and otherwise advertising, distributing, offering for sale, and selling goods bearing and/or using infringements of one or more of the Burberry Marks.

85. Defendants' infringing activities are likely to cause and are causing confusion, mistake, and deception among consumers as to the origin and quality of Defendants' Counterfeit Goods bearing and/or using the Burberry Marks.

86. Burberry has no adequate remedy at law and is suffering irreparable injury because of Defendants' actions, while Defendants are earning a substantial profit.

PRAYER FOR RELIEF

87. WHEREFORE, Plaintiffs demand judgment on all Counts of this Complaint and an award of equitable relief and monetary relief against Defendants as follows:

a. Entry of temporary, preliminary, and permanent injunctions pursuant to 15 U.S.C. § 1116, 28 U.S.C. § 1651(a), The All Writs Act, and Federal Rule of Civil Procedure 65 enjoining Defendants, their agents, representatives, servants, employees, and all those acting in concert or participation therewith, from manufacturing or causing to be manufactured, importing, advertising or promoting, distributing, selling, or offering to sell their Counterfeit Goods; from infringing, counterfeiting, or diluting the Burberry Marks or the Burberry Copyrighted Work; from using the Burberry Marks or the Burberry Copyrighted Work, or any mark or design similar thereto, in connection with the sale of any unauthorized goods; from using any logo, trade name, copyright, trademark, or design that may be calculated to falsely advertise the services or goods of Defendants as being sponsored by, authorized by, endorsed by, or in any way associated with Plaintiffs; from falsely representing themselves as being connected with Plaintiffs, through sponsorship or association, or engaging in any act that is likely to falsely cause members of the trade and/or of the purchasing public to believe any goods or services of Defendants, are in any way endorsed by, approved by, and/or associated with Plaintiffs; from using any reproduction, counterfeit, infringement, copy, or colorable imitation of the Burberry Marks or the Burberry

Copyrighted Work in connection with the publicity, promotion, sale, or advertising of any goods sold by Defendants; from affixing, applying, annexing, or using in connection with the sale of any goods, a false description or representation, including words or other symbols tending to falsely describe or represent Defendants' goods as being those of Plaintiffs, or in any way endorsed by Plaintiffs and from offering such goods in commerce; from engaging in search engine optimization strategies using colorable imitations of Plaintiffs' names, copyrights, or trademarks and from otherwise unfairly competing with Plaintiffs.

b. Entry of a temporary restraining order, as well as preliminary and permanent injunctions pursuant to 28 U.S.C. § 1651(a), The All Writs Act, and the Court's inherent authority enjoining Defendants and all third parties with actual notice of an injunction issued by the Court from participating in, including providing financial services, technical services, or other support to Defendants in connection with the sale and distribution of non-genuine goods bearing and/or using counterfeits and/or infringements of the Burberry Marks and the Burberry Copyrighted Work.

c. Entry of an Order pursuant to 28 U.S.C. § 1651(a), The All Writs Act, and the Court's inherent authority that, upon Plaintiffs' request, those acting in concert or participation as service providers to Defendants, who have notice of the injunction, cease hosting, facilitating access to, or providing any supporting service to any and all e-commerce stores, including but not limited to the E-commerce Store Names through which Defendants engage in the promotion, offering for sale and/or sale of goods using counterfeits and/or infringements of Plaintiffs' Marks.

d. Entry of an Order pursuant to 28 U.S.C. § 1651(a), The All Writs Act, and the Court's inherent authority authorizing Plaintiffs to serve the injunction on the e-commerce store's registrar(s) and/or the privacy protection service(s) for the E-commerce Store Names to

disclose to Plaintiffs the true identities and contact information for the registrants of the E-commerce Store Names.

e. Entry of an Order pursuant to 28 U.S.C. § 1651(a), The All Writs Act, and this Court's inherent authority that, upon Plaintiffs' request, any Internet marketplace website operators, administrators, registrar and/or top level domain (TLD) Registry for the E-commerce Store Names who are provided with notice of an injunction issued by the Court identify any e-mail address known to be associated with Defendants' respective E-commerce Store Name.

f. Entry of an Order pursuant to 28 U.S.C. §1651(a), The All Writs Act, and the Court's inherent authority, authorizing Plaintiffs to serve the injunction on any e-mail service provider with a request that the service provider permanently suspend the e-mail addresses that are or have been used by Defendants in connection with Defendants' promotion, offering for sale, and/or sale of goods using and/or bearing counterfeits and/or infringements of the Burberry Intellectual Property.

g. Entry of an Order pursuant to 15 U.S.C. § 1116, 28 U.S.C. § 1651(a), The All Writs Act, and the Court's inherent authority, that upon Burberry's request, Defendants and the top level domain (TLD) Registry for the E-commerce Store Names, and any other e-commerce stores used by Defendants, or their administrators, including backend registry operators or administrators, place the E-commerce Store Names on Registry Hold status for the remainder of the registration period for any such name, thus removing them from the TLD zone files, which link the E-commerce Store Names, and any other e-commerce store names being used and/or controlled by Defendants to engage in the business of marketing, offering to sell, and/or selling goods bearing counterfeits and infringements of the Burberry Intellectual Property, to the IP addresses where the associated e-commerce stores are hosted.

h. Entry of an Order pursuant to 28 U.S.C. § 1651(a), The All Writs Act, and the Court's inherent authority, canceling for the life of the current registration or, at Burberry's election, transferring the E-commerce Store Names, and any other e-commerce store names used by Defendants to engage in their counterfeiting of the Burberry Intellectual Property at issue, to Burberry's control so they may no longer be used for unlawful purposes.

i. Entry of an Order pursuant to 28 U.S.C. § 1651(a), The All Writs Act and the Court's inherent authority authorizing Burberry to request any Internet search engines or service provider referring or linking users to any URL of the E-commerce Store Names, which are provided with notice of the order, to permanently disable, de-index, or delist all URLs of the E-commerce Store Names and/or permanently disable the references or links to all URLs of the E-commerce Store Names used by Defendants to promote, offer for sale, and/or sell goods bearing counterfeits and/or infringements of the Burberry Intellectual Property, based upon Defendants' unlawful activities being conducted via the E-commerce Store Names as a whole and via any specific URLs identified by Burberry.

j. Entry of an order pursuant to 15 U.S.C. § 1116 and the Court's inherent authority, requiring Defendants, their agent(s) or assign(s), to assign all rights, title, and interest, to their E-commerce Store Name(s) and any other e-commerce store names by Defendants to Burberry and, if within five (5) days of entry of such order Defendants fail to make such an assignment, the Court order the act to be done by another person appointed by the Court at Defendants' expense, such as the Clerk of Court, pursuant to Federal Rule of Civil Procedure 70(a).

k. Entry of an Order pursuant to 15 U.S.C. § 1116 and the Court's inherent authority, requiring Defendants, their agent(s) or assign(s), to instruct all search engines to

permanently delist or deindex the E-commerce Store Name(s) and any other e-commerce store names used by Defendants, and, if within five (5) days of entry of such order Defendants fail to make such a written instruction, the Court order the act to be done by another person appointed by the Court at Defendants' expense, such as the Clerk of Court, pursuant to Federal Rule of Civil Procedure 70(a).

l. Entry of an Order pursuant to 28 U.S.C. § 1651(a), The All Writs Act, and this Court's inherent authority that, upon Burberry's request, any Internet marketplace website operators and/or administrators who are provided with notice of an injunction issued by the Court, including Amazon.com, Inc., permanently remove from the multiple platforms, which include, inter alia, a Direct platform, Group platform, Seller Product Management platform, Vendor Product Management platform, and Brand Registry platform, any and all listings and associated images of goods bearing and/or using counterfeits and/or infringements of the Burberry Intellectual Property via the e-commerce stores operating under the E-commerce Store Names, including but not limited to the listings and associated images identified by the "parent" and/or "child" Amazon Standard Identification Numbers ("ASIN") on Schedule "A," , and upon Burberry's request, any other listings and images of goods bearing and/or using counterfeits and/or infringements of the Burberry Intellectual Property associated with or linked to any other alias e-commerce store or seller identification names being used and/or controlled by Defendants to promote, offer for sale and/or sell goods bearing and/or using counterfeits and/or infringements of the Burberry Intellectual Property.

m. Entry of an Order pursuant to 28 U.S.C. § 1651(a), The All Writs Act, Federal Rule of Civil Procedure 65, and this Court's inherent authority that upon Burberry's request, Defendants and any Internet marketplace website operators and/or administrators who are

provided with notice of an injunction issued by this Court immediately cease fulfillment of and sequester all goods of each Defendant bearing one or more of the Burberry Intellectual Property in its inventory, possession, custody, or control, and surrender those goods to Burberry.

n. Entry of an order requiring, upon Burberry's request, Defendants to request in writing permanent termination of any messaging services, e-commerce store names, usernames, and social media accounts they own, operate, or control on any messaging service, e-commerce marketplace, and social media website.

o. Entry of an Order requiring Defendants to account to and pay Burberry for all profits earned resulting from Defendants' trademark counterfeiting and infringing and unfairly competitive activities and that the profit award to Burberry be trebled, as provided for under 15 U.S.C. § 1117, or that Burberry be awarded statutory damages from each Defendant in the amount of two million dollars (\$2,000,000.00) per each counterfeit trademark used and product type offered for sale or sold, as provided by 15 U.S.C. § 1117(c)(2) of the Lanham Act.

p. Entry of an order requiring the Cybersquatting Defendant to account to and pay Burberry for all profits resulting from the Cybersquatting Defendant's cybersquatting activities and that the profit award to Burberry be trebled, as provided for under 15 U.S.C. § 1117, or that Burberry be awarded statutory damages from the Cybersquatting Defendants in the amount of one hundred thousand dollars (\$100,000.00) per Cybersquatted E-commerce Store Name used as provided by 15 U.S.C. § 1117(d) of the Lanham Act.

q. Entry of an award pursuant to 15 U.S.C. § 1117 (a) and (b) of Burberry's costs and reasonable attorneys' fees and investigative fees associated with bringing this action.

r. Entry of an order pursuant to 15 U.S.C. § 1116, 28 U.S.C. § 1651(a), The All Writs Act, Federal Rule of Civil Procedure 65, and the Court's inherent authority that, upon

Burberry's request, Defendants and any financial institutions, payment processors, banks, escrow services, money transmitters, e-commerce shipping partner, fulfillment center, warehouse, storage facility, or marketplace platforms, and their related companies and affiliates, identify and restrain all funds, up to and including the total amount of judgment, in all financial accounts and/or sub-accounts used in connection with the E-commerce Store Names or other alias seller identification names used by Defendants presently or in the future, as well as any other related accounts of the same customer(s) and any other accounts which transfer funds into the same financial institution account(s), and remain restrained until such funds are surrendered to Burberry in partial satisfaction of the monetary judgment entered herein.

s. Entry of an Order pursuant to 28 U.S.C. § 1651(a), The All Writs Act, and this Court's inherent authority that, upon Burberry's request, the applicable governing operators and/or administrators for the E-commerce Store Names who are provided with notice of an injunction issued by the Court, disable and/or cease facilitating access to the E-commerce Store Names and any other alias e-commerce store or seller identification names being used and/or controlled by Defendants to engage in the business of marketing, offering to sell, and/or selling goods bearing and/or using counterfeits and/or infringements of the Burberry Intellectual Property.

t. Entry of an Order requiring Defendants to account to and pay Plaintiffs for all damages sustained by Plaintiffs in consequence of Defendants' copyright infringement described above together with appropriate interest thereon; Defendants be required to account to Plaintiffs for, and disgorge to Plaintiffs, and to pay to Plaintiffs, all the gains, profits, savings, and advantages realized by Defendants from their acts of copyright infringement described above; Plaintiffs' be awarded, at their election, statutory damages within the provisions of Sections 504(c) of the Copyright Act, 17 U.S.C. § 504(c), enhanced to reflect the willful nature of Defendants'

infringement, instead of an award of actual damages or profits, and be awarded their costs and disbursements incurred in this action, including reasonable attorney fees pursuant to 17 U.S.C. § 505.

u. Entry of an award of pre-judgment interest on the judgment amount.

v. Entry of an Order requiring Defendants, at Burberry's request, to pay the cost necessary to correct any erroneous impression the consuming public may have received or derived concerning the nature, characteristics, or qualities of Defendants' products, including without limitation, the placement of corrective advertising and providing written notice to the public.

w. Entry of an Order for any further relief as the Court may deem just and proper.
